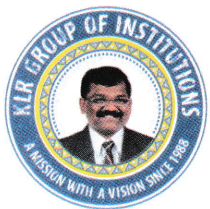

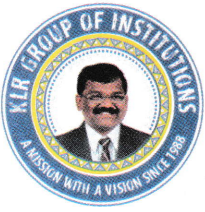

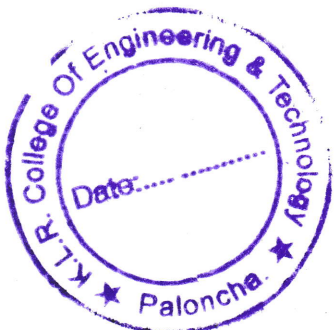
Statutory Declaration under the RTI Act 2005
