

ORDER:

In the reference (1) read above, the UGC has Conferred Autonomous Status to KLR College of Engineering & Technology (QT), B.C.M. Road, Paloncha, Bhadradi Kothagudem (Dt), Telangana affiliated to JNT University Hyderabad, Kukatpally, Hyderabad, for a period of Five (05) Years from the Academic Year 2025-2026 to 2029-2030 as per clause 7.4 of the UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in autonomous Colleges) Regulations, 2023 for Autonomous Colleges and subsequent regulations issued from time to time by the University.

Also, the UGC has stated that the autonomy granted colleges shall abide by all the provisions of the UGC Regulations for Autonomous Colleges. The college shall apply, in the prescribed format to the UGC, for extension of autonomous status at least three months before the completion of autonomy period.
